Instructions to Bidders

1. Scope of Works

The **Government College of Engineering and Technology** (Employer) invites quotations for the construction of works as detailed in the table given below-

The successful bidder will be expected to complete the works by the intended completion date specified above

- 2.Qualification of the bidder: The bidder shall provide qualification information which shall include:-
- (a) Total monetary value of construction works performed for each year of the last 3 years:
- (b)Income tax clearance certificate from the concerned IT circle;
- (c)Report on his financial standing; and
- (d)Details of any litigation, current or during the last 3 years in which the bidder is involved, the Parties concerned and disputed amount in each case.

3.To qualify for award of the contract the bidder:-

- (a) Should have satisfactorily completed as a prime contractor at least one similar work of value not less than Rs. 500,000 in the last three years;
- **(b)**Should possess valid electrical license for executing building electrification works (in the event of the works being sub contracted, the sub-contractor should have the necessary license);

4. Bid Price

(a) The contract shall be for the whole works as described in the Bill of quantities, drawings and technical specifications. Corrections, if any, shall be made by crossing out, initialling, dating and re writing.



- **(b)**All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- (c) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- (d)The rates should be quoted in Indian Rupees only.

5. Submission of Quotations

- **5.1**The bidder is advised to visit the site of works at his own expense and obtain all information that may be necessary for preparing the quotation.
- **5.2**Each bidder shall submit only one quotation.
- **5.3**The quotation submitted by the bidder in two bid format:

Technical Bid:

The technical bid comprising of following documents should be sealed in envelope "A" mentioning Technical Bid on top of the envelope. The envelope must mention package no. and name.

- i) The Technical Bid should be submitted as per the bid format. (Annexure-I)
- ii) A compliance list against the technical specifications as per Annexure-I should be provided.
- iii) Proof of Registration of the bidder.
- v) Copies of PAN Card and GST registration no.
- vi) Signed copy of the tender document, with company seal, agreeing to the terms & conditions must be submitted.

All documentary proof must be listed on the letterhead of the company. This part of bid should not contain any "Price information".

Financial Bid:

- i) Financial bid should indicate item wise price for the items mentioned in the technical bid as per the format. (Annexure-II)
- ii) The price quoted should be F.O.R GCET Jammu.
- iii) All duties and other levies payable by the supplier under the contract shall be included in the unit price.
- iv) The prices quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- v) The Prices should be quoted in Indian Rupees only.
- vi) The Financial bid should be sealed in envelope "B" mentioning Financial Bid on top of the envelope. The envelope must mention package no. and name.
- **5.4**The bidder shall seal the quotation in an envelope addressed to the **Government College of Engineering** and **Technology**, **Chak Bhalwal**, **Jammu** (**J&K**). The envelope will also bear the following identification: Quotation for **Electrical Minor Work**.



Do not open before **05-Mar-2020 16:00** (time and date of quotation opening).

5.5Quotations must be received in the office of the **Government College of Engineering and Technology**, **Chak Bhalwal**, **Jammu (J&K)** not later than the time and date given in the letter of invitation. If the specified date is declared a holiday, quotations shall be received up to the appointed time on the next working day

5.6Any quotation received by the **Government College of Engineering and Technology** ,**Chak Bhalwal**, **Jammu (J&K)**, (Employer) after the deadline for submission of quotations will be rejected and returned unopened to the bidder.

6. Validity of Quotation

Quotation shall remain valid for a period not less than 55 days after the deadline date specified for submission.

7. Opening of Quotations

Quotations will be opened in the presence of bidders or their representatives who choose to attend on the date and time and at the place specified in the letter of invitation.

8.Information relating to evaluation of quotations and recommendations for the award of contract shall not be disclosed to bidders or any other persons not officially concerned with the process until the award to the successful bidder is announced.

9.Evaluation of Quotations

The Employer will evaluate and compare the quotations determined to be substantially responsive i.e. Which

- (a) Meet the qualification criteria specified in clause 3 above;
- (b) Are properly signed; and
- (c) Conform to the terms and conditions, specifications and drawings without material Deviations.

10.Award of contract

The Employer will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price and who meets the specified qualification criteria.



10.1Notwithstanding the above, the Employer reserves the right to accept or reject any Quotations and to cancel the bidding process and reject all quotations at any time prior to The Award of contract

10.2The bidder whose bid is accepted will be notified of the award of contract by the Employer Prior to expiration of the quotation validity period.

11.Performance Security

Within 15 days of receiving letter of acceptance, the successful bidder shall deliver to the **Government College** of Engineering and Technology ,Chak Bhalwal, Jammu (J&K) (Employer) the performance security (either a bank guarantee or a bank draft in favour of the Employer) for an amount equivalent of 10% of the contract price. The Performance Security shall be valid till the expiry of the period of maintenance of the work, specified in clause 12.

12.Period of Maintenance:

The "Period of Maintenance" for the work is **12** months from the date of taking over possession or one full monsoon season whichever occurs later. During the period of maintenance, the contractor will be responsible for rectifying any defects in construction free of cost to the Employer.

13.Purchase of all construction materials including cement and steel as per the specifications (ISI certification marked goods wherever available) shall be the responsibility of the contractor.
