College of Engineering and Technology, Jammu, Chak Bhalwal-181122 Jammu (J&K) for a period of 05 years from the academic year 2024-2025 to 2028-2029 as per clause 7.4 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.
