Due to poor response against Notice No.GCET/22/Adm/516-520 dated:-12-12-2022 regarding applications invited from students for seeking Financial Assistance out of Students Aid Fund for the session 2022-23, the last date has been extended upto 30.01.2023 for receiving applications from the interested eligible students of the following Categories of this Institution for seeking Financial Assistance out of Students Aid Fund during the session 2022-23:-

- Orphan students with no earnings.
- Children from broken family having no economic support to continue their studies.
- Physically challenged students or handicapped and the students suffering from chronic diseases and dependent on lifelong medical support. This also includes students having handicapped father with small earnings.
- Students having family income of less than Rs.≤ 10,000/- per month. (Rupees Ten Thousand only).
The applications should reach the office of the Registrar GCET Jammu upto 30.01.2023 alongwith the documentary proof of Eligibility for Financial aid, 2022-23.

Documents/ Certificates to be attached with the application

Students falling under above mentioned categories have to attach the following verified documents in support of their claim along with applications:

- Fresh Income Certificate from area concerned Executive Magistrate in case of a Non- Government Employee. (Category -C&D)
- Income certificate from Head of institution in case of Govt. Employee (Category - C&D)
- Medical Certificate in respect of physically challenged persons issued by the Medical Board. (Category -C)
- Undertaking that such benefit is not drawn from any other scheme by the student. The affidavit should be duly attested by the concerned area Executive Magistrate/Judicial Magistrate. (Category - A,B,C & D)
- Copy of Death Certificate and affidavit in the case of demise of the earning parents of the student claiming aid under orphan category (Category -A)
- Divorce Certificated or Court order in case of children from Broken families (Category -B)
- Aadhar Card copy.
- Bank Account No. with IFSC code, (Photo copy of pass book of the concerned student).
- Marks card of previous semester.

NOTE:-

- Those students already availing benefit under any other scheme are not eligible to apply.
- The Photocopies of the documents submitted should be self- attested.
