

Downloaded tender document without cost of tender fee will not be accepted. Last date of submission of tender is 23.01.2023 by 2.00 PM and shall be opened on the same date at 3.00 PM. The filled in tender form can be submitted through speed post or by hand in the office of Principal, GCET, Jammu.

TERMS AND CONDITIONS

1. The tendering Firm should be registered with the Govt. of UT of Jammu and Kashmir.
2. The tendering Firm should have GSTIN, PAN and experience for catering services.
3. The tenderer must have the valid Trade License for running of Catering Services from the competent authority recognized by FSSAI act 2006.
4. The tenders should be accompanied with the copy of Registration Certificate GSTIN and PAN of the tendering firm.
5. The Principal, GCET, Jammu reserves the right to accept or reject tender without assigning any reason thereof.
6. The Payment shall be made after satisfactory completion of job subject to the recommendation by the Alumni Committee.
7. The taxes under rules shall be deducted at source from the bill of the approved tenderer.

8. Rates quoted should be inclusive of all taxes/Labour charges.
9. The quantity may increase or decrease as per the requirement.
10. The conditional Tenders shall be rejected out rightly.
11. There should be no overwriting, correction and rates should be quoted both in words and figures.
12. The envelope in which tender is submitted must be super-scribed as **"Tender for Providing of catering services (Lunch) and allied utilities.**
13. The crockery should be of good quality and neat & clean.
14. The approved tenderer will provide good quality food and proper hygiene shall be ensured at the cooking area and while serving the Lunch.
15. Tender Fee Rs.200/- in the shape of DD in favour of the Principal, GCET, Jammu.
16. EMD of Rs. 2000/- in the shape of CDR/TDR pledged in favour of the Principal, GCET, Jammu should be enclosed with the tender document.
17. Dispute if any, arising shall be decided by the Principal/Refreshment Committee, GCET, Jammu and the decision shall be binding upon all the parties.
