- 1. In case last date, is declared a Government holiday, the sealed tenders shall be received till next working day up to 03.00 PM.
- 2. The Intending tenderer/s will have to enclose fresh requisite earnest money in the shape of CDR/FDR from any Nationalized/Scheduled Bank Pledged to the Principal, GCET, Jammu along with the tender/s separately failing which the tender/s shall be out-rightly rejected even if the quoted rates are lowest.
- 3. The rates tendered for should be quoted both in words and figures and should be inclusive of all taxes including GST if any.
- 4. Tenders should be filled-in clearly and with same ink with rates written both in figures and words. No additions/alterations/overwriting etc. of any sort be made in tender. Correction if any done in tender should be made clearly and properly authenticated by the tenderers under his signature.
- 5. No conditional tender will be accepted/entertained.
- 6. Where-ever a tenderer claims to be authorized representative/agent / dealer sole proprietor/Distributor of a company, he shall enclose a written authority of the company declaring him as such.
- 7. The CDR/FDR of the successful tenderers will be released only after satisfactory completion of the defect liability within the warranty period if any from the date of supplying of the items. - 8. Payment shall be made by the institute against consignment delivered, inspected, accepted and properly surveyed and material brought on stock in the concerned stock register of the institute. No advance payment shall be made.
- 9. As soon as the acceptance of the tender is communicated to the successful tenderer the contract shall be final and binding on him. The earnest money in the shape of CDR/FDR of the tenderer who back out or withdraws tender or fails to abide by it after acceptance shall be forfeited.
- 10. If the successful tenderer fails to supply the goods as per supply order or fails to deliver the goods within time period specifically mentioned in the supply order, the Institute shall be at liberty to arrange supplies from other alternate sources at the risk and cost of tenderer.
