- 1. The Firm/Printing Agency must be registered with J&K Govt.
- 2. The tender must be accompanied with earnest money in the form of CDR/FDR worth of Rs. 400/-(Rs. Four Hundred only) pledged to the Principal Govt. College of Engineering and Technology, Chak Bhalwal, Jammu.
- 3. There should be no overwriting or cutting in the rates quoted. The rates should be quoted for each page and should be written both in figures as well as in words inclusive of all taxes.
- 4. The sample of material regarding printing, specification and size can be had from the personal section of the Principal, GCET, Jammu.
- 5. The material should be supplied as per specification and sample.
- 6. The job should be completed within a period of 03 days after the date of issuance of job order.
- 7. Taxes admissible under rules if any shall be deducted from the bill at the time of payment.
