Whereas, as per Job Order No. GCET/Acctts/2019-20/825-29 dated 10.10.2019, you were allowed to provide sanitation services/petty maintenance works in this Institute; and

Whereas, this Institute came across an Experience Certificate bearing No. GCET/Accounts/2019-20/825-29 dated 21.12.2020 allegedly issued by this Institute and submitted by your agency; and

Whereas after scrutinizing the official record, it was discovered that the said experience certificate is forged and fabricated document ,created by your agency with the intent to secure a tender and procure the Job Order; and

Whereas, this forgery was brought to light when this Institute received a communication bearing No. GEM/2023/B/4129413/01 dated 06.12.2023 from Konkan Railway Corporation Ltd. requesting verification of the above- mentioned Experience Certificate ,which was submitted by your agency in the tendering process; and

Whereas, this Institute has taken stringent action by reporting the matter to the Crime Branch Jammu via communication No. GCET/24/Adm/08-09 dated 02.01.2024, followed by a reminder No. GCET/24/Adm/550-551 dated 16.05.2024, requesting legal action against your agency; and

Whereas, this Institute has again received a communication bearing No. JKMSCL/DGMT-L/2024-25/386-87 dated 21.06.2024 from Jammu & Kashmir Medical Supplies Corp. Ltd., regarding the authentication of the same fake and forged Experience Certificate that was submitted by your agency in their tendering process, which was also reported to the Crime Branch Jammu via communication No. GCET/Adm/24/807-808 dated 09.07.2024, for taking appropriate against you for repeatedly using the said fake and forged Experience Certificate in the tendering process of Govt departments/agencies; and

Whereas, a show cause Notice bearing No. GCET/2024/Adm/836-838 dated 18-07-2024 was issued to you, providing an opportunity to explain your position or appear Established: 1994
